MINISTERIAL ORDER NO. L:001/09

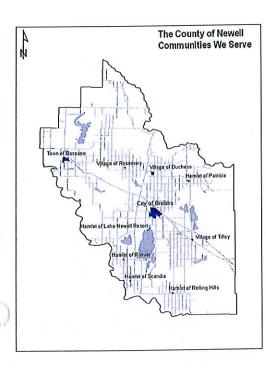

Message from the General Manager

I believe that the Board of Directors has given excellent direction and every decision has enabled Newell Regional Services Corporation (NRSC) to move in a forward direction. My thanks to the Board members for effective governance and excellent guidance and support.

I also want to thank the City of Brooks, Brooks Council, administration and all of Brook's staff for the cooperation, assistance and patience during the 2008 and 2009 start-up of the Corporation. NRSC would have had a difficult time in making progress to reach the goals of starting a new Corporation.

A word of thanks also to the County of Newell No. 4 for their patience and guidance. County Council, administration and staff have been exceptional in providing information and assistance to NRSC.

I would also be remiss if I did not thank the Province of Alberta and Alberta Transportation and Infrastructure for the contributions in funding the project, on a regional basis and to provide the vehicle for the concept of the regional water system to come to a reality.

The staff and employees of NRSC have also made a contribution to our goals considering that until January 2010, all employees worked for diverse employers. 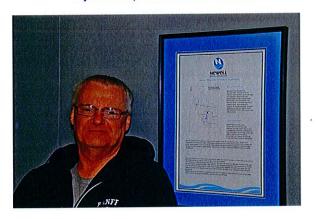

Project Report and Summary



The first pipeline project (Phase 1-Contract #1- Pipeline to Tilley) was started in November 2008. Work progressed over the winter and the pipeline was completed in late summer of 2009. The reservoir in Tilley, as well as the distribution pump house clear-well and the water distribution system within the Village of Tilley had to be cleaned and flushed. Components in the old plant had to be removed and the transmission main connected to the old plant. MJB Enterprises Ltd. was awarded the project of Contract #3 (Upgrades to Treated Water Storage

Reservoirs) in each of the southern communities. A part of their work was to make the connection from treated water pipeline to the old WTP in Tilley. There was also work done on controls, monitoring equipment and the SCADA system. The Village of Tilley was on a temporary connection while this work was being performed. Sampling and testing of treated water was required in the reservoir, clear-well and water distribution system in order to provide this information to Alberta Health Services, as information to consider for removal of the Boil Water Order.





While the transmission main to Tilley was being constructed work had begun on the expansion of the Water Treatment Plant, in Brooks. In July of 2009, the City of Brooks turned over the asset of the WTP but continued to lease the plant from NRSC. This was done because of the liability during the performance of construction and the operation of the WTP had to continue without interruption. City of Brooks operators provided that necessary continuance in the performance of their duties and would be familiar with the new plant upon completion. Work has been progressing well and during the end of April, the plant will

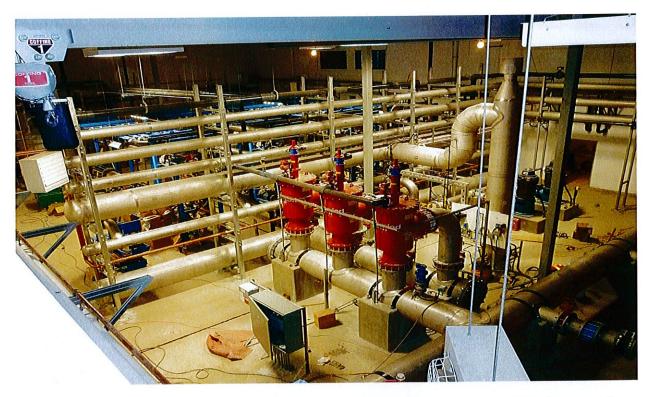
be producing water through the new system. Work will then begin on the demolition of the existing components of the WTP.



This is a photograph of the PALLS membrane rack. It will replace the existing sand filters. The vertical cartridges have yet to be installed. These units were purchased 2 years before construction of the new WTP was started.

The control room below, will have all lab testing equipment and the computers for the SCADA system. From this room we can remotely view what will be happening in each of the communities.





This photograph shows most of the filtration system as well as the strainers and the piping for raw and treated water. Under all of this equipment and piping is the treated water storage reservoir. Each of the 4 PALLS racks will treat up to 8,000,000 mld (8,000 m3) totaling 32,000 m3 per day.

While the WTP expansion was being constructed, Brute Force Oil Field Hauling, from Spruce Grove, Alberta was awarded Contract #2- Pipeline to Rolling Hills. The project got off to a great start, initially, but soon began to go off the rails by the end of September. On November 20, 2009, Brute Force was forced into receivership by the Courts. Since that time their bonding company and NRSC have been negotiating a Completion Contract to complete that project. Brooks Asphalt and Aggregate has been awarded the completion of the pipeline to Rolling Hills, Rainier and Scandia. We expect completion of that project by April 30, 2010.

Certain unpaid creditors of Brute Force have filed liens against land that the pipeline is on (and some lands where there is not a pipeline, in error). The bonding company and NRSC have been working diligently to have all liens removed, but it has been a slow and tedious legal process.

During the winter of 2009 and spring of 2010; Brooks Asphalt and Aggregate has been successful in almost completing Phase 2-Contract #1- Pipeline Through Brooks. That pipeline is connected to the WTP and passes through Brooks city limits ending at the City/County border. From that point, the last pipeline contract (closing on March 18, 2010) will be awarded and the anticipated completion date is December 2010. The will bring the transmission main to Patricia and Rosemary.





While each of the transmission main projects have been under construction, MJB Enterprises from Medicine Hat have been upgrading and renovating each of the Water Treatment Plants in Tilley, Lake Newell Resort, Rainier, Scandia and Rolling Hills; under Contract #3- Upgrades to Treated Water Reservoirs. An additional storage reservoir is being constructed at Lake Newell Resort; as well as a booster station to pump water to Rolling Hills.

The transmission mains, storage reservoirs and WTP in Brooks are all well under construction or have been completed. The completion date for the project is December 31, 2010. At that time Patricia and Rosemary will be connected to the system. Bassano Council has had a resolution to apply for a portion of Phase 4 of the project, which would be the transmission main to Bassano.

There has been a lot of interest from groups, residents and developers in connecting to the transmission mains. Future connections will be part of a Board of Directors approved strategy.

Status of Funding Program

The original Grant was approved for the following:

- Phase 1: Construction of Water treatment Plant addition and treated water pipeline to the Village of Tilley
- Phase 2: Addition of treatment capacity for the City of Brooks and construction of treated water pipelines to the Village of Rosemary and the Hamlets of Rolling Hills and Patricia and to Lake Newell Resort
- Phase 3: Addition of treatment capacity for the City of Brooks and construction of treated water pipelines to the Hamlets of Rainier and Scandia
- Phase 4: Addition of Dissolved Air Flotation process equipment at regional plant and construction of treated water pipeline to Bassano.

The total of **Phase 1&2**, eligible for grant funding and approved was \$45,452,000.

Phases 3&4 were not approved.

Since beginning the first pipeline to Tilley and the work at the Water Treatment Plant the following changes and additions have occurred:

- ✓ Capacity increase from 32 MLD to 40 MLD- Bassano industrial demand and Duchess joining the project
- ✓ Incorporate backwash treatment pond into design
- ✓ Addition of perimeter fencing and vehicle access gate
- ✓ On-Line redundant PLC (Palls System)
- ✓ Added maintenance area to footprint of the WTP
- ✓ Addition of security features (swipe card door locks and monitoring cameras)
- ✓ Addition of 4 raw water pumps vs 1 raw water pump identified in the original study
- ✓ Addition of ammonia feed system
- ✓ Addition of second floor offices for NRSC
- ✓ Addition of metering chambers and PRV vaults
- ✓ Addition of pipeline for Scandia and Rainier (changed design route)
- ✓ Upsize additional capacity for pipeline through Brooks (additional 5 1/4 sections)
- ✓ Additional capacity for Duchess in the pipelines

The additions and incorporation of parts of Phase 3 have resulted in an increase to the program from \$45,452,000 to \$46,513,910. This also includes an estimate of all engineering costs and UROW costs for registration and land costs.

AT is aware of the increase due to additions to the program as well as the additional costs.

Summary of Corporate Information

Newell Regional Services Corporation was established on October 27, 2008, subject to a Minister of Municipal Affairs order. The order was received on January 12, 2009; thus legalizing the Municipal Controlled Corporation of Newell Regional Services.

With the establishment of the Corporation we could now move ahead into building the Corporation.

Finding an insurance provider to purchasing paper and pencils; from purchasing an accounting system to researching a benefits provider. These tasks were all required in order to become a functioning Corporation. Policies and procedures had to be developed, accounting systems put into place, procedures established and a plan for the work that was to be performed had to be identified. Those were just a few of the many tasks that had to be accomplished.

By December 31, 2009 everything was ready for Newell Regional Services Corporation to walk on its own. The City of Brooks has been instrumental in providing funds and services in order to bridge the gap and all Council, Administration and City staff deserves a round of applause for stepping up to the "water tap".

Without the City of Brooks support; NRSC would not be in the position it is today.

Newell Regional Services is meeting all lawful Corporate requirements of both the MGA and Business Incorporations Act. We have Board of Directors approved policies and procedures in place and are in the development stage of many more.

Next steps will be finalizing budgets and working towards establishing an effective water rate. In the next year we anticipate a 5 year strategic plan to be developed and approved by the Board of Directors, as a guideline for operating, maintaining and searching for a balanced and efficient budget.
